## Cat & Dog Registration Application Form

*Animal Management (Cats & Dogs) Act 2008 (AMCDA)- Sections 44, 45, 46, 54, and 57*

### IMPORTANT INFORMATION - PLEASE READ CAREFULLY

- It is mandatory for dogs aged 12 weeks and over to be registered within 14 days after starting to keep the dog in the area or becoming the owner of the dog. It is not a mandatory requirement in the Longreach Regional Council for cats to be registered, however it is strongly recommended.
- To register a cat or dog, the owner must complete this registration form in full.
- The cat or dog's Prescribed Permanent Identification Device ("microchip") number must be supplied with the application.
- Animal registration fees apply annually – refer to Council's Fees and Charges Schedule.
- If the cat or dog is desexed – owner **MUST** supply a signed veterinary certificate or other evidence, stating that it has been de-sexed. If evidence is not supplied at time of registration, the customer must pay registration fee for unsterilised animal and apply for refund of difference in fee on supply of veterinarian certificate.
- The owner of the cat or dog must ensure that the dog bears the registration device (tag) at all times.
- If any information stated on this form for the owner or animal changes, the owner must give the Council notice of the changed information **within 7 days**. Changed information may include, but is not limited to, change of residential address, change of owner, if the animal becomes deceased or is transferred out of the region, etc.

#### Microchip Obligations for Owners of Cat/s or Dog/s

*Animal Management (Cats & Dogs) Act 2008 – Section 14 & 43Y*

- A person who is or becomes an owner of a cat or dog that is not implanted with a PPID must ensure the cat or dog is implanted with a PPID before it is 12 weeks old.
- A person must not supply a cat or dog to anyone else if it is not implanted with a PPID. Supply may include by sale, give away or trade.

#### Prohibition on Keeping Dogs within the Longreach Regional Council local government area:

1. More than 3 dogs over the age of 3 months on an allotment in the designated town area;
2. More than 1 dog over the age of 3 months on a multi-residential premises;
3. Any of the following breeds anywhere in the local government area:
  - American Pit Bull Terrier or Pit Bull Terrier;
  - Dogo Argentino;
  - Fila Brasileiro;
  - Japanese Tosa;
  - Perro de Presa Canario or Presa Canario

- I am the owner and responsible person for the dog(s) or cat (s) described in this form, and hereby apply for the registration with Longreach Regional Council. I have read and understand Longreach Regional Council's relevant terms and conditions.
- I recognise that failure to comply with the Council's Local Laws and any relevant provisions of the *Animal Management (Cats and Dogs) Act 2008* may result in Council taking enforcement action against myself.
- I am aware that the number of dogs or cats kept at this property cannot exceed the allowable number of dogs or cats on a property of this size as stated in Council's *Local Law No. 2 (Animal Management) 2011 Section 6 Requirement for approval and Subordinate Local Law No. 2 (Animal Management) 2011 Section 6 Circumstances in which keeping animals requires approval & Schedule 2 Requirement for approval to keep animal*.
  - 2 dogs over the age of 3 months may be kept on an allotment in a designated town area without an approval.
  - An approval is required to keep 3 dogs over the age of 3 months on an allotment in a designated town area – "excess dog".
  - It is prohibited to keep more than 3 dogs over the age of 3 months on an allotment in a designated town area.
  - It is prohibited to keep more than 1 dog over the age of 3 months on multi-residential premises.
  - 2 cats over the age of 3 months may be kept on an allotment in a designated town area without an approval.
  - An approval is required to keep 3 cats over the age of 3 months on an allotment in a designated town area – "excess cat".
  - It is prohibited to keep more than 3 cats over the age of 3 months on an allotment in a designated town area.
- I have a proper enclosure to prevent my dog or cat from wandering or escaping from the property.
- I will ensure that my dog or cat will be under effective control at all times if in a public place.
- I will keep the animals in accordance with the *Minimum Standards for Keeping Animals*, under *Local Law No. 2 (Animal Management) 2011- Section 8*.
- I will ensure that my dog or cat wears the prescribed registration device (Registration Tag) at all times. Should the registration tag become lost or damaged, I must make an application to Council for a replacement registration tag.
- I will contact Council to inform of any changes to the registration information, including change of address, ownership, or status (e.g. microchipped, de-sexed, deceased, transferred out of the Council area, etc.) within 7 days of the change taking place.
